

Consultation on Economics Learning Standards

What is this about?

Under the Tertiary Education Quality Standards Agency (TEQSA) legislation, all higher education institutions are required to be able to demonstrate that their internal processes for design and approval of each degree, and the standards achieved by their students, are benchmarked against external standards. Published learning standards provide a reference point for benchmarking. They are guidelines about what graduates of a program should know and be able to do.

The Australian Government has commissioned the development of learning standards in university economics programs under the auspices of an Office for Learning and Teaching (OLT) Fellowship. The development of these learning standards has the support of the Australian Business Deans Council and the Economics Society of Australia.

A Working Party, consisting primarily of academic economists, is developing the standards through collaboration and wide consultation. The process and outcomes are being guided by an Expert Advisory Group, which includes senior economists in the private and public sectors. Why should I participate in consultation?

This is an opportunity to have your say in developing Economics Learning Standards for Australia. Each workshop will be an open forum where the aim, process and outcomes to date will be explained, followed by a discussion. The aim of the workshop is to capture feedback to be shared with the Working Party in developing the next draft.

The consultative process is also an opportunity to reflect on our purpose as economics educators. What are the core knowledge and skills that we want our graduates to have attained?
